Welcome to Cleaver Holding GmbH and thank you for your interest in our website and our company.

We attach great importance to the protection of your data and your privacy. It is in your legitimate interest to keep control of all personal information that you submit to Cleaver Holding GmbH. According to the German Telemedia Act (TMG), you also have the right to

- withdraw consent to the collection, processing and use of Internet usage data at any time without stating a reason and
- review Internet user data connected to you or to your pseudonym that may have been stored.

Collection, processing and use of data

If we want to collect, process or use personal data from your visit, we will inform you. You decide what personal information we receive and how we may process and use these.

To improve our website, we collect statistical information such as the number of visitors to each individual website. A record is made of computer and browser type, Internet provider, date and time, and access to data files in the download area. This is used only for internal purposes, with no personal references.

Through public websites, we only collect personal data for processing and use if you voluntarily decide to enter them or expressly give your consent.

We would like to explain the specific purposes:

Contact

The information you stated in the contact form is stored at Cleaver Holding GmbH. These data allow us to get in touch with you. If you do not wish to have further contact with us, a notification is sufficient to block the data, and delete where appropriate.

Newsletter and email

Entering your email address for the mailing of newsletters results in having your email address at Cleaver Holding GmbH. This way, you receive the latest information from Cleaver Holding GmbH. You can unsubscribe from this information at any time, for example by a brief note via email.

We have to point out that confidentiality of sensitive personal data you transmit to us by unencrypted e-mail cannot be ensured regarding third parties.

Data Maintenance

We correct and complete stored data as soon as changes become known to us. If necessary, we also inform the data recipients. We delete stored data through an automated process, when the statutory or contractual retention period has expired or if the data is no longer needed.

Advertising

Cleaver Holding GmbH does not sell or rent any personal information to persons or organizations outside of Cleaver Holding GmbH. These data may be used internally for marketing purposes, if you have not objected to this. We respect the limits drawn by the Data Protection Act and by competition law.

Self-protection possibilities and anonymity

What information you entrust to us during your visit is up to you.

Anonymity

You can remain anonymous while visiting any public website of Cleaver Holding GmbH. You can leave our sites at any time. We only collect statistical data that cannot be traced back to you to improve our website.

Pseudonyms

When using our contact form, it is up to you to just provide a contact email address. We do not try to ascertain the owner of that address.

Consent / voluntariness

Without your express consent, there is no automated collection, processing or use of personal data from your visit to our website. For example, if you request a newsletter from us, you enter the data for this voluntarily.
